



## **Annexure-A**

### **Expression of Interest (EOI) for Empanelment of Architect Consultants/ Structural Engineers/Quantity Surveyors/Firms for providing Comprehensive/Individual Consultancy services to HPPWD and other Departments for Building projects**

Expression of Interest (EOI) is invited from qualified Architect Consultants/Structural Engineers/Quantity Surveyors/Firms for providing comprehensive/individual consultancy services to HPPWD for carrying out the detailed survey and soil investigation of the building project site, preparation of the contour site plans, preparation of the architectural drawings, detailed structural designs & drawings based on latest IS Codes including seismic criteria using latest software. DPRs of the Building projects based on HPSR -2020 with latest market rates and CPWD latest specifications and preparation of the detailed estimate incorporating latest related guidelines as per ECBC & Solar Passive buildings as per scope of specific work.

#### **Empanelment Categories:-**

**The empanelment categories shall be as under:-**

- Category-A:** For projects costing more than Rs 10 crore.  
**Category-B:** For projects costing more than Rs 2 crore . up to Rs 10 crore.  
**Category-C:** For projects costing up to Rs 2 crore.

#### **Note:-**

- (i) In case of Architect Consultant applying for empanelment, he shall have to associate himself with a qualified Structural Engineer and a qualified Quantity Surveyor who qualify the work experience and eligibility criteria mentioned herein and shall have to submit documentary proof to this effect at the time of application for empanelment.
- (ii) In case of Structural Engineer applying for empanelment, he shall have to associate himself with a qualified Architect Consultant and a qualified Quantity Surveyor who qualify the work experience and eligibility criteria mentioned herein and shall have to submit documentary proof to this effect at the time of application for empanelment.
- (iii) In case of Quantity Surveyor applying for empanelment , he shall have to associate himself with a qualified Architect Consultant and a qualified Structural Engineer who qualify the work experience and eligibility criteria

mentioned herein and shall have to submit documentary proof to this effect at the time of application for empanelment.

- (iv) In case of registered firm applying for empanelment, it shall have to associate itself with the qualified Architect Consultant, Structural Engineer and Quantity Surveyor who qualify the work experience and eligibility criteria mentioned herein and shall have to submit documentary proof to this effect at the time of its application for empanelment.

**Validity of Empanelment:** - The empanelment shall be valid for the period of 5 years from the date of empanelment and can be updated time to time as per requirement.

### **SCOPE OF WORK**

#### **(A) At Planning stage of building project:**

- To carry out survey of the site by Total Station after obtaining the authentic revenue papers from the client department related to project site duly issued by the competent authority, preparing contour site plan and carrying out detailed soil investigation including determination of safe bearing capacity of the soil as required for the building project. All the existing site details including position of the underground/over ground utilities, trees and existing structures should be depicted clearly in the contours site plans enabling preparation of the architectural drawings in an optimum manner minimizing possibility of any revision of the architectural drawings at later stage. The detailed soil investigations should be carried out taking into account all the prevailing site conditions in order to minimize the possibility of any alteration and revision of the architectural drawings/structural design at any later stage. Regarding methodology to be used for carrying out the detailed soil investigations, he shall obtain instructions from the employer and shall carry out the detailed soil investigations accordingly.
- To prepare sketch/conceptual drawings which shall include all the proposed components of the project i.e. approach roads, retaining structures, building portion, landscape portion, location of waste disposal management system, rain harvesting system, position of likely shifting of the existing underground/over ground utilities as per project requirement and presentation of sketch drawings/conceptual designs including their revision till the sketch/conceptual drawings are approved by the competent authority/Architect wing.

- To submit the architectural drawings and seek approval from urban local bodies/TCP (as the case may be) with the assistance of HPPWD and client department.
- To prepare and supplying the detailed Architectural working drawings which shall include master plan, line plans detailed plans, elevations/sectional elevations and 3D views/walkthroughs. The detailed working drawings shall be worked out for civil work, electrical work including specialized electrical and mechanical work (where required) and horticulture work. The working drawings for civil work shall include drawings for site development including retaining structures, approach roads, waste disposal management system, design on rainwater harvesting system and detailed working drawings of all the components of the building which should be got approved/ vetted from the Architectural Wing of HPPWD. The working drawings for the Electrical Installations and specialized E&M work considering requisite power load shall be worked out and submitted. Detailed design on fire safety system, HVAC/Ventilation system / Mechanical system, design on Electronics Communication System, lift, Elevator, Escalator, solar passive architecture system/design and any other drawings as desired by HPPWD in relation to requirement of the project shall be worked out and submitted. The working drawings of the horticulture related work shall also be submitted as per project requirement. All working drawings should be got approved by the concerned wing of the department and Architectural wing.
- To draw and submit to HPPWD the detailed specifications for Civil, Electrical Installation works, specialized E&M works and Horticulture work as per project requirement. The detailed specifications shall have to be got approved from the Architectural Wing.
- To work out and submit the detailed structural designs & drawings of the building duly vetted from any of the NITs /IITs or PEC Chandigarh/like institutes.
- To prepare and submit DPR (5 hard copies & soft copy) of the project based on these Architectural and Structural designs/ drawings to the entire satisfaction of Client department/HPPWD. The detailed estimates of the work for civil/ electrical/ horticulture components of the project shall be required to be vetted by the competent authority of the respective wing of HPPWD.

**(B) At Construction stage of Building Project:-**

- To make 5 mandatory site visits by Architectural consultant during construction stage of the work at mutually agreed periodical intervals with the Engineer-in-Charge in order to ensure that site proceeds in accordance with the contract documents/drawings/specifications and clarifying any decision w.r.t. interpretation of the drawings/specifications as required by the Engineer-in-Charge. He shall submit the site visit report to HPPWD within 7 days of his site visit. The site visit report will be substantiated with site photographs and related documentation.
- To associate further with a Landscape Architect, MEP consultant and Acoustical Consultant as per requirement of the particular project.
- To submit any revised architectural drawing /structural design of the project during execution due to unprecedented site constraints appearing at site or changes requested by client department in rare case.
- To provide any other services normally rendered by the Architect Consultant/Structural Engineer/Quantity Surveyor and not referred to in above.

**(C) At completion/post construction stage of the building project :-**

- To get Green building rating from the approved agency or to make the building ECBC compliant, if required.
- To submit 3 sets of As built drawings to HPPWD after completion of the project.

**Qualification and Experience Criteria**

The Architect Consultants/Structural Engineer/Quantity Surveyor/Firms applying for empanelment should have extensive experience of work in hill area/hill states in the works of appropriate magnitude w.r.t. respective category as mentioned above for empanelment. Minimum qualification and work experience criteria shall be as under:-

## FINANCIAL ELIGIBILITY CRITERIA:-

(For all i.e. Architect Consultant/Structural Engineer/Quantity Surveyor/Firm)

Category-A	Works costing more than Rs 10 cr.	The intending applicant should have an annual average turnover of Rs 15 Lacs during the last 3 (Three) financial years ending 31 <sup>st</sup> March 2022.

The Architect Consultant/Structural Engineer/Quantity Surveyor/Firm applying for empanelment should have registered office at any appropriate place with sufficient staff within the state of Himachal Pradesh and will submit documentary proof in this regard. In case, he is not having the registered office and staff at the time of making his application for empanelment, in that case he will have to furnish an undertaking stating therein to establish office duly equipped with all required staff, tools and plants as may be required for execution of work in the event of award of consultancy work. He must have latest licensed software's so as to complete the awarded work within time frame. He will be required to arrange for additional manpower, machinery and equipments, if required, during course of execution. He will have to carry out the detailed soil investigation of the project site including safe bearing capacity through a recognized and registered agency and as per methodology approved by the Engineer-in-Charge.

### Terms and Conditions:-

1. As the time is the essence of the contract agreement, the ability and competence of the intending applicants to render the required services within the specified time frame will be the major factor while deciding the selection of the Architect Consultants /Structural Engineers/Quantity Surveyors/Firms for panel.
2. The intending applicant(s) should satisfy themselves before applying for empanelment that they meet all the above qualifying criteria. The applicant(s) not fulfilling the qualifying criteria/conditions for empanelment as specified above will not be considered for empanelment.
3. The empanelment panel shall be shortlisted based on the fulfillment of the eligibility and work experience criteria mentioned herein above.
4. The interested applicant(s) /firms having experience of above specialized jobs and having their own in-house expertise capacity and resources are required to submit



their E.O.I proposals for appropriate category duly supported by documentary proof describing their key staff (including other consultants to be associated with) and other relevant information of organization, detail of relevant experience along with certificate/documentary evidence of the works undertaken duly filled in the annexures (except payment schedule annexure) specified herein.

5. The application shall be signed by the intending applicant himself i.e. being Architect Consultant /Structural Engineer/Quantity Surveyor. In case of firm, it must be signed by an authorized partner of the firm.
6. In case the intending applicant is Architect consultant, attested copies of the valid registration certificate of Council of Architecture (COA) shall be submitted.
7. In case of the intending applicant is a Structural Engineer/Quantity Surveyor/Firm, the details of Architect Consultant to be associated with the execution of work shall be submitted along with the attested copy of the valid registration certificate of Council of Architecture (COA) in respect of the concerned Architect Consultant.
8. In case of the intending applicant being a firm, attested copy of the valid certificate of incorporation as partnership firm from appropriate authority shall be submitted. An undertaking mentioning the name of the Architect Consultant, Structural Engineer and Quantity Surveyor to be associated by the firm along with their willingness and other criteria parameters as mentioned above shall be submitted.
9. The attested copy of the annual turnover certificate from Chartered Accountant for last 3 years shall have to be submitted along with the application for empanelment.
10. The HPPWD may modify/amend the EOI conditions, change the selection process, and reject any or all applications without assigning any reasons as per future requirements.
11. Any modification/amendment of the EOI document shall be posted in the website of HPPWD.
12. The interested agencies/consulting firms shall have to submit their expression of interest proposals with non refundable fee of application as Rs. 5000/- only through **on line payment** of any scheduled bank in favour of Executive Engineer, Division No. III, HPPWD Shimla-3, (payable at Shimla) through registered post/speed post and their application for empanelment with complete documents and Annexures duly filled in should reach the office of Chief Engineer(SZ), Nirman Bhawan, Nigam Vihar, Shimla-2 on or before 28.3.2023 up to 10.30 AM and shall be opened on the same day at 11.30 AM.. Expression of interest received after this will not be considered for empanelment.
13. The panel for the consultancy services shall be shortlisted after due scrutiny of the applications and the documents submitted along with the application. The scrutiny committee, if feels so, may require verification of any of the document submitted by the applicant and in that eventuality, the applicant is required to respond promptly in order to avoid any delay in the selection process.
14. The applicant selected for empanelment shall be intimated separately and the list of the shortlisted consultants will be uploaded on the website of the department.
15. Application for empanelment once submitted shall not be allowed to be withdrawn at any stage under any reason whatsoever and no fees of registration will be returned back.
16. The applicant must have a valid Permanent Account Number (PAN) of the Income Tax Department and GST Number.
17. Joint ventures/ consortium of firms is not allowed to apply for empanelment.

18. The retired Architects/Structural Engineers/Executive Engineers/Assistant Engineers from HPPWD may apply for empanelment in the appropriate class and category after 6 months of their retirement from the service for any of the category for which they fulfill the qualification and work experience criteria mentioned above. In such cases, their work experience shall be taken from the day of their retirement and counting the preceding years of the service rendered in the department. However, they shall be required to seek permission in this regard from the office of the Engineer-in-Chief, HPPWD and while seeking permission, they shall be required to submit their application along with their Curriculum Vitae (CV) mentioning their work experience and other relevant information. The scrutiny committee may decide their cases for empanelment on the basis of their qualification and work experience in the department. They shall, however be exempted from having GST number at the time of submission of application.

**Other conditions (for award of consultancy and execution of work at site):-**

1. For awarding the particular work to the consultant, the Engineer-in-Charge will invite tender for RFP mentioning details of the work which will also be e-mailed to the eligible & empanelled consultants of the respective category.
2. The empanelled / consultants shall quote their lump-sum bid amount duly supported with complete justification and submit the same to the Engineer-in-Charge / Employer for consideration and award thereof.
3. The amount of earnest money to be deposited shall be as under which shall be deposited only through online mode as per GoHP instructions.

4. The time period up to approval of the DPR as per scope of specific work shall be as under:-

Category-A	Works above Rs 10 crore.	60 days
Category-B	Works costing Rs 2.00 -10.00 crore	40 days

5. The above time period shall be applicable up to approval of the DPR only. However, the consultant shall remain associated with HPPWD till completion of the building project and obtaining Green building rating (where so required) and submission of the As built drawings to HPPWD.
6. In case the work is not started without any valid reason within 7 days after the award of work by the Engineer-in-Charge, the work will be rescinded without serving any notice.
7. For non-completion of the work as per above stipulated time period, penalty @ 0.25 % of the total cost of the awarded amount per day for each day of delay shall be imposed subject to maximum of 10% of the total awarded amount.
8. In case of failure to complete the work even after the imposition of the maximum penalty, the awarded work and empanelment shall be cancelled and he shall be debarred from making application for empanelment for a minimum of 5 years.

9. If the Consultant(s) with lowest rates happens to be a non performer /defaulter as per the terms and conditions stated above, in that case the consultant with 2<sup>nd</sup> lowest bid offer may be offered the consultancy job for award to avoid further delay, provided it is so required in exigency of the work.
10. The detailed soil investigations of the project site shall be carried out taking into account all the prevailing site conditions in order to minimize the possibility of any alteration and revision of the architectural drawings/structural design at any later stage. 
