- 2. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, then during the period of validity of the panel, no fresh offer of appointment on promotion shall be made for to such incumbents for a period of one year from the date of refusal or till a next vacancy arises whichever is later. - 4. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
