**"OFFICE ORDER"**

State of HP and further in pursuance of Additional Chief Secretary (Personnel) to the Government of Himachal Pradesh letter No. PER(AP)C-B(2)-1/2014-VII dated 28.03.2022, on the recommendations of Departmental Screening Committee, the services of following Junior Engineers (Civil) working on contract basis, who have completed two years of continuous service as on 31.03.2022 are hereby regularized in the pay scale of Level 11 of HPCS (RP) Rules, 2022 with immediate effect as under:-

The above official(s) shall continue to work at present place of posting after their regularization.

The above regularization is subject to the following conditions:-

1. Only those Junior Engineers(Civil) are to be allowed to join on regularization who have completed minimum 2 years continuous service on contract basis as on 31.03.22. Apart from this, it may also be ensured that no fresh Departmental inquiry/ Vigilance case is pending against any one of the above officials. If in any case it comes to the notice of controlling officer, the matter may be brought to the notice of this office.
2. The Contractual appointees so regularized shall be fixed at the minimum of the time scale of the post.
3. The regularization shall be subject to verification of character and antecedents, as provided under relevant rules.
4. Their appointment shall be subject to the production of Medical Certificate of fitness from the District / Medical Officer of the Govt. Hospital.
5. They are liable to service in any part / area where HP PWD has its organization.
6. They are required to produce all original certificates in support of their qualification / technical education , age, Citizen of India / Himachal Pradesh Bonafide and belonging to any reserved class against which they are proposed to be appointed at the time of joining the post.
7. They shall have to submit assets & liability statement.

8. They should give a declaration that they have not more than one living spouse.
9. They will be governed by the CCS & CCA Conduct Rules.
10. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
11. They will be required to take oath affirm on the following form.

I \_\_\_\_\_ do swear / solemnly affirm that I will be faithful and either bear true allegiance to the constitution of India as by laws established and that I shall carry out the duties of my office with loyalty, honesty and impartiality.

12. If the above regularized officials have been transferred to other station, He/She will be treated regularized where presently working.


If they accept the offer on the terms and conditions given above, they should report for duty to controlling officer within a period of 15 days, failing which the offer shall be cancelled automatically.
