 - 2. Before relieving the above official(s) it may be ensured that:
 - a) Junior Technicians (Work Inspectors) who have been promoted possess at least two years certificate course in the trade of Draughtsmanship (Civil) or its equivalent from a recognized ITI or from an Institute duly recognized by the Central/ H.P. Government which is subject to condition to production of authentic copy of NTC (National Trade Certificate) issued by NCVT.
 - If any discrepancy on any account comes to the notice, the official(s) may not be relieved and the matter may be brought in the notice of HOD.
 - 4. The above promotion is subject to review due to any consequential administrative reasons.

- 5. The above promotees will join at the place of his/her posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall deemed to be withdrawn automatically for one year.
- 6. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, then during the period of validity of the panel, no fresh offer of appointment on promotion shall be made for to such incumbents for a period of one year from the date of refusal or till a next vacancy arises whichever is later. In case of non-acceptance of reasons to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
- 7. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
- 8. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.
- 9. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official(s).
