Consequent upon their promotion to the post of Junior Technician (Work Inspector), the posting orders of the officials are hereby made with immediate effect in the public interest as under :-



The officials posted outside the radius of 25 KMs., from the present place of posting shall be entitled for TTA and Joining Time.

Before relieving/joining, the promotee, controlling officers are directed to verify genuineness of all the certificates produced by the candidates especially qualification certificates to the effect that it is valid and recognized by the HP Government, confidentially, and necessary entries to this effect be recorded in the Service Book of the official. Any lapse in this regard shall be personal responsibility of controlling officer & it would be viewed seriously.

Before the above orders are implemented, the concerned Head of the Office will ensure the promotee fulfill the appended conditions:-

1. The promotees will join at the place of his/her posting on promotion within 15 days from the issuance of this order failing which the promotion orders shall be deemed to be withdrawn automatically for one year or till the next DPC or vacancy arises, whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.
2. No promotee has right to forgo the promotion in the public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or till the next DPC or vacancy arises, whichever is later.
3. The above promotion is subject to review due to any consequential administrative reasons.
4. Those who have been posted outside the sub cadre/tribal area will have to serve in these areas as and when it is administratively required.
5. That in case of any factual error/omission is detected later on, the promotion orders so issued will be withdrawn and concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved to next station or before joining.
6. Before relieving the official to join the new place of posting on promotion, it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said officials, if so, same may be brought to the notice of this office immediately. The work and conduct of the officials may also be kept in view before implementing the orders.


