

Executive Engineer & above) who had dealt with Road, Bridge and Buildings work during their service carrier are requested to apply on prescribed proforma and selection Criteria for Empanelment of Third Party Quality Monitors(TPQMs) can be obtained from this office or downloaded from departmental web site hppwd.hp.gov.in to be empanelled as Third Party Quality Monitors(TPQMs)for inspection of Quality of works being executed by the HPPWD, under State works, NABARD & CRF works. The applicant can apply by post or through e-mail to the undersigned on the e-mail address se-qc-hp@nic.in. The application alongwith C.V should reach in this office by **20.03.2024**. The empanelment as TPQMs would be for a period of one year and its continuation will depend upon the satisfactory performance of the TPQM evaluated at the end of one year. The person already working as National Quality Monitor(NQM) & State Quality Monitors(SQM) for inspection of PMGSY works will not be eligible for appointment as Third Party Quality Monitor.
