OFFICE ORDER

Whereas Sh. Inder Singh, Senior Assistant from HPPWD Divn. Paonta has been promoted to the post of Supdt.Gr.II. and further posted in HPPWD Divn. Shillai in the Level 12 of HPCS (Revised Pay) Rules 2022 vide this office order No. PWE-79-1-Supdt.Gr.II.Prom./ESI-14850-14950 dated 17-02-2024.

And whereas, Further in compliance to this office order dated 17.02.2024, the Executive Engineer, HPPWD Divn. Poanta has relieved the official vide his office order No.PWP-CB-E-I-P-F.Transfer/2023-24-11548-53 dated 20.02.2024 and further directed to join his services in HPPWD Divn. Shillai, but after lapse of 29 days from date 20.02.2024 to date neither he has joined in Shillai Divn. nor any intimation of his joining has been received in this office.

And whereas, as per condition incorporated in promotion order dated 17.02.2024 at Sr.No. 2, the official has to join at his place of posting on promotion after availing the joining time as admissible under the rules i.e 5 days failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next DPC whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

And whereas, Sh. Inder Singh, Sr.Asstt. was also offered promotion to the post of Supdt.Gr.II. vide this office order No. PWE-79-1-Supdt.Gr.II.Prom./ESI-11754-11800 dated 16.03.2022 & office order No.PWE-79-1-Supdt.Gr.II.Prom/ESI-11801-850 dated 16.03.2022, but the official had forfeited the promotion of Supdt.Gr.II.

And whereas view of above depicted position, as per condition incorporated in promotion order dated 17.02.2024 at Sr.No. 2, the official has failed to join his services in HPPWD Divn. Shillai within 5 days after his reliving, hence, the promotion order of Sh. Inder Singh, Sr.Asstt. issued vide this office order dated 17.02.2024 has been withdrawn automatically for one year or till the date of next DPC whichever is later.

The above official is hereby retained in HPPWD Divn. Paonta against vacancy, but he is further informed that he cannot claim his retention at the present station and in the public interest he can be transferred as Sr.Asstt. to any part of the state where department has its organization.
