**MEMORANDUM**

Whereas, Sh. Shubham Thakur, Junior Engineer (Civil) while posted under HPPWD., Spiti Divn. at Kaza has filed CWP No.4599/2024 titled as Shubham Thakur V/s State of HP & Ors. The matter was lastly listed before Hon'ble High Court on 12.06.2024, wherein following order has been passed:-

*3."Taking into consideration the fact that the request of transfer was made by the petitioner in the month of February,2024,in terms of Annexure P-2, appended with the petition, this petition is disposed of with direction that appropriate order on the representation of the petitioner be passed by the competent authority within a period of six weeks' from today and taking into consideration the fact that the petitioner has already completed more than three years of service at his place of posting, endeavor be made to place him at a station of his choice, if possible. However, in case, the station of his choice is not available, then, the petitioner may be transferred to some other place, which is not a backward/hard area. Pending miscellaneous applications, if any, also stand disposed of."*

And whereas, pursuant to the order passed by Hon'ble High Court, a fresh representation dated Nil of petitioner has been received through the Executive Engineer, HPPWD., Spiti Division at Kaza for his transfer to one of stations of choice mentioned as under:-

- 2.HPPWD., Sub Divn. Katrain under HPPWD., B&R Divn.Manali.

5. HPPWD., Sub Divn. Panarsa under HPPWD., B&R Divn.Thalout.
