

**HIMACHAL PRADESH

OFFICE ORDER

On the recommendation of the Directorate Sainik Welfare Ex-Servicemen Employment Cell Himachal Pradesh at Hamirpur vide letter No. DSW Ex-Cell OC-09/2024-12009-12 Dt. 07-06-2024, the following Ex-Serviceman is hereby offered appointment as Junior Draughtsman (Civil) on contract basis on fixed contractual emoluments equivalent to 60% of the first cell of the applicable level i.e. Level 6 of HPCS (RP) Rules 2022, subject to the acceptance and fulfillment of the usual as well as specific terms and conditions:-

The appointment shall be on contract basis initially for a period of one year from the date of joining the post, but contract can be reviewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without notice.

The above appointment has been ordered subject to the following terms and conditions: -

1. The appointment is on contract basis and he will be paid consolidated contractual amount i.e. equivalent to 60% of the first cell of the applicable level i.e. Level 6 of HPCS (RP) Rules 2022.
2. No travelling allowance will be paid to him for joining the post.
3. He shall not claim any right for the regularization in service at any time in future.
4. The appointment shall further be subject to terms and conditions of attached agreement and surety Bond for Rs.10,000/- on Non-judicial paper of Rs.3/- and Rs.15/- respectively which are to be executed before the Executive Magistrate before acceptance of joining report.
5. He will be entitled for one day casual leave after putting one month service. This leave can be accumulated up to one year. In addition to this other leave(s) shall be granted in accordance with instructions issued for contract employees by the Govt., from time to time. He shall not be entitled for medical reimbursement and LTC etc.
6. The appointment may be terminated at any time or on one month notice given by either side, viz, the appointee or the appointing authority. However, the appointing authority reserves the rights of terminating the services of the appointee forthwith or before expiry of the stipulated period of notice by making payment of a sum equivalent to the pay and allowances for the period of notice of the un expired period thereof.
7. He will produce medical certificate of fitness signed by the Chief Medical Officer indicating specifically whether he is suffering from any communicable disease or not.
8. If he has worked anywhere in any capacity, he should bring a clearance certificate from the authorities concerned before he can be permitted to take up the appointment in the department.
9. He should produce a certificate of approved character from 1st Class Magistrate or from two Gazetted Officers known to him at least for the last three years.
10. He will have to serve at any place where Himachal Pradesh Public Works Department has its Administrative units.
11. He should produce original certificates of educational qualification/technical education i.e. Matric/ Higher Secondary/ 10+2 /Diploma etc. Original certificates and testimonials in

support of his qualification, experience etc. should also be produced at the time of joining the department.

12. He will be required to take oath/ affirm in the following lines: -

"I do swear and solemnly affirm that I shall be faithful and bear true allegiance to India and to the constitution of India as be law established and that I will carry out the duties of office loyally, honestly and with impartiality, so help me God".

13. He will have to give a declaration that he has got only one living spouse and that he shall take prior permission of the Government before keeping more than one spouse in accordance with provision of Central Civil Services (Conduct) Rules-1964.


14. He should produce a certificate duly attested by the Magistrate 1st class to the effect that he is a bonafide resident of Himachal Pradesh, before he can be permitted to join the appointment in the department.

15. In case any declaration given and information furnished by the candidate proved to be false/ incorrect or if the candidate is found to have willfully suppressed any material information, he will be liable to be removed from service and for such other action as the Government may deem necessary.

16. He will be subject to the condition of services applicable to temporary civil Government servant and Central Civil Services (Conduct) Rules-1964 as applicable to Himachal Pradesh Government employees.

17. These orders can be withdrawn without giving any notice on administrative grounds.

If he is willing to accept the offer on the terms and conditions as mentioned above, he should report to the station/place of posting within 15 days from the issue of this appointment letter. His joining will be accepted after satisfying all above mentioned conditions.
