The Governor, Himachal Pradesh, on the recommendations of Departmental Screening Committee and in pursuance to the Chief Secretary to the Government of Himachal Pradesh letter No. PER(AP)-C-B(2)-2/2015 dated 2nd December, 2023 is pleased to regularize the services of the following Contract Assistant Engineers (Electrical), HPPWD in the Level-18 of Pay Matrix as per HPCS (RP) Rules, 2022, who have completed 02 years of continuous service as on 31.03.2024, with immediate effect, in the public interest:-

The terms and conditions of regularization of the above officers are as under:-

- 1. That on regularization, the officers shall be appointed on the minimum of the level-18 of pay matrix and fixation of pay will be done under the provisions of normal rules and orders/ instructions in force & issued from time to time.
- 2. The officers will be on probation for a period of 02 years from the date of joining the post. The period of probation is liable to be extended at the discretion of the Appointing Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority will render them liable to be discharged from service.

- 3. The officers will be liable to serve in any part of Himachal Pradesh.
- 4. The regularization shall be subject to the verification of character and antecedents, as provided by the HP Financial Rules.
- 5. The regularization of the officers shall be subject to the production of Medical Certificate of fitness from the Chief Medical Officer, DDU, Hospital, Shimla.
- 6. The Officers will be required to take an oath of allegiance/faithfulness to the Constitution of India (or make the solemn affirmation to that effect) in the prescribed form.
- 7. The Officer will be required to submit declaration in the prescribed form that in case he is married; he has only one living wife. In the event of having more than one wife living, the appointment will be subject to being exempted from the enforcement of the requirement in this behalf.
- 8. The other conditions of service including pay fixation etc. will be governed by the relevant Rules and orders / instructions in force & issued from time to time.
- 9. If any declaration given or information furnished by the officers proves to be false or if found to have willfully suppressed any material, information, he will be liable for removal from service and such other action as may be deemed necessary.
- 10. The Officers are required to produce all original certificates in support of their qualification/ technical education, age and belonging to any reserved class against which they are supposed to be appointed at the time of joining the post.
- 11. The Officers will not be entitled for any benefit of service rendered on contract basis, towards seniority, pay fixation etc.

If offer of appointment on the above terms and condition is acceptable to them, they may join within the period of one week after completion of all the codal formalities failing which the offer shall stand cancelled.
