OFFICE ORDER

Whereas Sh. Shyam Singh Verma, Sr.Asstt. while posted in HPPWD Divn. Kaza has filed CWP No.9878/2024 titled Shyam Singh Verma Vs State of HP & others before the Hon'ble High Court for his transfer from tribal area to station of choice (soft area). This writ petition has been decided on 27.09.2024 with the following orders: -

Learned counsel appearing on behalf of the petitioner submits that with respect to the grievances being raised in the present petition, an appropriate representation dated 03.07.2024 i.e. Annexure P-2 stands filed with the concerned quarter.

Learned Additional Advocate General submits that the representation so made shall be decided within a period of four weeks from today.

In view thereof, the present petition is disposed of, so also, pending miscellaneous application, if any.

And whereas in compliance to the orders passed by the Hon'ble High Court of Himachal Pradesh, the representation dated 03.07.2024 as well as representation dated 28.09.2024 submitted by Sh. Shyam Singh Verma, Sr.Asstt. has been examined and considered in this office wherein the official has requested to transfer him one of the station of his choice which are given as under:-

1. HPPWD Sub-Divn. Ochghat under Solan Divn.
2. HPPWD Sub-Divn. Solan under Solan Divn.
3. HPPWD Sub-Divn. Elect. Solan under Elect. Divn. No.I Shimla
4. HPPWD Divn. Solan
5. HPPWD Sub-Divn. Habban under Rajgarh Divn.

And whereas at present no post of Sr.Asstt. is lying vacant in his station of choice, except HPPWD Sub-Divn. Ochghat under Divn. Solan where one post of Sr.Asstt. has recently been fallen vacant due to promotion of Sh. Prem Chand, Sr.Asstt. to the post of Supdt.Gr.II.

The complete incumbency of Sh. Shyam Singh Verma, Sr.Asstt. is as under:-

Whereas, it is evident from the above incumbency that the petitioner Sh. Shyam Singh Verma, Sr. Asstt. has completed his normal stay at tribal area.


Now therefore, in view of above position, the representation of applicant Sh. Shyam Singh Verma, Sr.Asstt. is considered accordingly Sh. Shyam Singh Verma, Sr.Asstt. is hereby transferred from HPPWD Divn. Kaza to HPPWD Sub-Divn. Ochghat under HPPWD Divn. Solan with TTA/JT against vacant post with immediate effect in the public interest.

However, the department/competent authority has reserves the right to transfer him in accordance with transfer policy anywhere in the state where department has its own organization.


