No. PWD-A-E (1)/34-2024 Dated, Shimla-2, the 21-10-2024

ORDER

WHEREAS, Sh. Manoj Kumar, Assistant Engineer (Civil), was transferred from HPPWD Sub Division, Koksar to O/o ENC, HPPWD Shimla vide notification No. PWD-A-B (6)-8/2023-Loose dated 21.09.2024 but feeling aggrieved with above transfer order, he filed CWP No. 10814/2024 titled as Manoj Kumar, Vs. State of HP which was disposed of by the Hon'ble High Court on 24.09.2024 with following operative directions:-

"Learned counsel appearing on behalf of the petitioner submits that with respect to the grievances being raised in the present petition, an appropriate representation shall be made to the concerned authority within a period of three days from today.

2. On receipt of the same, the same shall be decided within a period of two weeks thereafter.

In view thereof, the present petition is disposed of, so also, pending miscellaneous application, if any."

WHEREAS, in pursuant to above orders passed by the Hon'ble High Court, the applicant Shri Manoj Kumar, Assistant Engineer, made a representation on 24.09.2024 to the undersigned with request to adjust him against any of the five stations i.e. E.O in 6th Circle Kullu, HPPWD Kullu, Panarsa Sub

Division under Thalout Division, Babeli Sub Division under Manali Division at Katrain, Katrain Sub Division under Manali Division at Katrain, Manali Sub Division under Manali Division at Katrain;

WHEREAS, before taking decision on the representation in pursuance to the directions of Hon'ble High Court, the applicant was afforded an opportunity of being heard on 05.10.2024 and during the course of hearing, the applicant has requested to adjust him against any of above five stations of choice keeping in fact that he is at the verge of retirement;

WHEREAS, it has been found that there is no post lying vacant at the choice stations given by the applicant and due to non-availability of vacant post at the choice station(s) given by the applicant, it is not possible to adjust him at any of these stations. Moreover, the applicant is holding Group-A, Gazetted post and he can be posted anywhere in the State as per administrative requirements;

THEREFORE, representation of Sh. Manoj Kumar, Assistant Engineer (Civil) is hereby rejected with direction to join his duties as per transfer orders issued vide notification dated 21.09.2024 and submit charge assumption report within 5 days from issuance of these orders.
