Before the above orders are implemented, the concerned Controlling Officer shall ensure that the promotee fulfill the appended conditions:-

1. It may be ensured that above promotees are Matriculate from recognized board/ institution and has successfully completed Departmental training course of 03 months duration.

2. The above promotees after relieving will join at the place of his/her posting on promotion within or after availing the joining time as admissible under the rules as given below failing which the promotion

orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with

reference to withdrawal of promotion will be issued separately.

3. No promotees has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting/appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.

4. The above promotion is subject to review due to any consequential administrative reasons.

- 5. Those who have been posted outside the sub-cadre/ tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
- 6. That in case of any factual error/ omission is detached later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relived on promotion to the next station.

7. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is

pending against the said official.

8. The Controlling Officer(Concerned) shall strictly adhere to the instructions issued by the department of Personnel to the Govt. of HP vide letter No.Per(AP-B)E(3)-17/2022-Part dated 4.09.2023 for implementation of order.
