OFFICE ORDER

Whereas, Sh. Sher Singh S/o Late Sh. Giaru Ram R/o Village Noti Post Officer Sholi Tehsil Nankhari District Shimla (HP) was transferred from HPPWD B&R Division Rampur to HPPWD B&R Division Nirmand vice Sh Shyara Kumar, Excavator –Cum-Loader Operator vide this office order No. PWE-1334 9(Driver)2023- ES-III- 7899-7903 dated 24.12.2024, upon the approval of competent authority. Feeling aggrieved against this order, Sh. Sher Singh, Excavator-Cum-Loaden Operator has filed CWP No 493 of 2025- titled as Sher Singh Vs. State of H.P & org before Hon'ble High Court of H.P. This writ petition was listed for hearing on 07.01.2025 and the same was disposed of by the Hon'ble Court with the following directions:-

2. In the light of the fact that the petitioner has already completed his normal tenure at the present place of posting, this writ petition is disposed of with the direction that in the event of petitioner filing a fresh representation, for his adjustment at some other nearby area, within a period of one week from today, let the same be decided by the Authority concerned sympathetically, within a period of two week's as from the date of receipt thereof. Till the decision in the representation, the petitioner be allowed to continue to serve, where he is presently posted. Pending miscellaneous applications(s), if any, also stand disposed of.

And whereas, in compliance to the directions passed by the Hon'ble Court and as per representations of the petitioner received on 9.01.2025, the personal hearing was fixed on 17.01.2025. On said day he appeared in person and made submission orally as well as by written statement.
