OFFICE ORDER


Whereas Sh. Rakesh Kumar, Junior Assistant from HPPWD Divn. Kullu has been promoted to the post of Sr.Asstt. and further posted in HPPWD Divn. Thalout in the Level 11 of HPCS (Revised Pay) Rules 2022 vide this office order No. PWE-79-1-Sr.Asstt.Prom.11259-309 dated 22.10.24 and further adjusted in HPPWD Kangra Zone at Dharamshala vide this office order No. PWE-79-1-Sr.Asstt.Prom.11481-90 dated 22.10.24.

And whereas, as per condition incorporated in promotion order dated 22.10.2024 at Sr.No. 2, the official has to join at his new place of posting on promotion after availing the joining time as admissible under the rules i.e 5 days failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next DPC whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

And whereas, the official after lapse of 3 months 6 days vide his representation dated nil, received through Chief Engineer, HPPWD Mandi Zone Mandi letter No. 15104-05 dated 16.01.2025 has requested for forgoing of promotion /adjust him in his old place of posting due to his family adverse circumstance.

And whereas in view of above depicted position, as per condition incorporated in promotion order dated 22.10.2024 at Sr.No. 2, the official has failed to join his services in HPPWD Kangra Zone at Dharamshala, hence, the promotion order of Sh. Rakesh Kumar Jr.Asstt. issued vide this office order dated 22.10.2024 has been withdrawn automatically for one year or till the date of next DPC whichever is later.

The above official is hereby retained in HPPWD Sub-Divn. Bhuntar under Divn. Kullu against vacancy, but he is further informed that he cannot claim his retention at the present station and in the public interest he can be transferred as Jr.Asstt./Clerk to any part of the state where department has its organization.
