- 1. The permanent absorption shall be strictly in the applicable level in the Pay Matrix in terms of the Civil Services (Revised Pay) Rules, 2022 corresponding to the pre revised Pay Band + Grade Pay of that post as per H.P. Civil Services (Revised :pay) Rules, 2009. In case of any official working in higher pay in the parent cadre as a result of grant of benefits under ÄCPS, (benefit under revised pay structure shall be protected on absorption as a measure personal in terms of the F.D. (Regulation) O.M. dated 11.05.2012, dated 20.02.2014 and as per, Rule-7(111) read with-Ru1e-3 of the H.P. Civil Services (Revised Pay) Rules, 2022.
- 2. The officers upon permanent absorption shall continue to draw their annual increments on normal date(s) of increment(s) which they as usual, used to draw in their own pay scales on the posts they held in the Engineering Wing of Forest Department prior to their absorption in the borrowing office/organization.
- 3. The above officials being absorbed shall be placed at the bottom in the cadre of Assistant Engineer (Civil) and seniority shall be determined on the basis of their absorption in the Department.
- 4. The pensionary benefits of the officers will be regulated as per the instructions of the State Government issued from time to time.
