Whereas, Sh.Chirag Kalia, Junior Engineer, HPPWD presently posted at HPPWD Division Kalpa, Sub Divn.Pooh, Distt. Kinnaur,HP has filed CWP No.4402/2024 titled Chirag Kalia Vs. State of HP before Hon'ble High Court which was lastly listed on 23.12.24 when following order has been passed by the Hon' ble Court:-.

3. Learned counsel for the petitioner submits that the petitioner has, as of now, completed three summers and two winters at his current place of posting, thereby making him eligible for consideration for a transfer in accordance with the applicable transfer policy.

In view of the above submission, the petitioner is permitted to make a fresh representation to respondent No.2 within a period of one week from today. If such representation is preferred, the competent authority shall consider and decide the same in accordance with law within a further period of two weeks. The order so passed shall also be communicated to the petitioner.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.

The main ground of case filed by the applicant is for his transfer from tribal area to soft area/ station of choice after completion of normal stay in tribal area

The applicant Sh.Chirag Kalia, JE(Civil) vide representation dated nil received on 3.01.2024 has requested for his transfer to one of the station(s) of choice given as under:-

- 1.HPPWD Divn. Hamirpur.
- 2.HPPWD Divn.Bhoranj
- 3.HPPWD Divn.Tauni Devi
- 4.HPPWD NH Divn.Hamirpur
- 5.HPPWD Divn.Palampur.
