OFFICE ORDER

Cr the recommendation of Departmental Promotional Committee, Eh. Raman Kumar, Jr. Tech. (Elect.), DoB:-14.02.69 and presently por a under HPPWD Elect. Divn. Palampur, who possess regular full time ITI ficate o two years duration in the trade of Electrician/Wireman from an inflicate cluly recognized by the State/Central Govt. with five years regular service is hereby promoted to the post of Junior Engineer (Elect.) in the pay scale of Level 11 of HPCS (RP) Rules, 2022 on regular basis with immediate effect in the public interest.

The official has to exercise option under F.R.22 read with fule 8 of HPCS(RP) Rules,2022 for the purpose of fixation of his pay against the post of Junior Engineer (Elect.) within one month from promotion.

Consequent upon his promotion to the post of Junior Engineer (Elect.), Sh. Raman Kumar is hereby further posted under HPPWD Elect. Divn. Palampur against vacancy with immediate effect in the public interest.

The above official may not be posted in his home sub division, if any.

The official(s) posted outside the radius of 25 KM is entitled for TTA/ joining time.

Before the above orders are implemented, the concerned Controlling Officer shall ensure that the promotee fulfill the appended conditions:

1. It may be ensured that above promotee possess above mentioned technical qualification from recognized institution.

2. The above promotee after relieving will join at the place of his/her posting on promotion within or after availing the joining time as admissible under the rules as given below failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

Distance between the old and the new Joining time headquarters admissible 30 Km or less 1 day 5 days

3. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for



refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting/appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.

4. The above promotion is subject to review due to any consequential

administrative reasons.

5. Those who have been posted outside the sub-cadre/ tribal area will have to serve in difficult sub-cadre as and when it is administratively required.

6. That in case of any factual error/ omission is detached later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relived on promotion to the next station.

7. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is

pending against the said official.
