6. Similar work done certificate & copy of the same be attached with the application.
7. The intending Contractors are requested to see the site of the work before submitting the tender.
8. The offer of the tender shall remain valid upto 75 days after the opening of tender.
9. The tender shall be awarded to the lowest bidder if his tendered amount is within limit of (+) 5% of the amount put to tender, otherwise the tender will be cancelled and recalled.

10. The Executive Engineer reserves the right to reject/accept any or all the tenders without assessing any reason.
11. Bidder will have to furnish Undertaking that machinery will be stationed/ stand by as the location prescribed, Time to Time, by Engineer-in-Charge during non-working hours/ days.
