Before relieving/Joining the promotee, controlling officers are directed to ensure that all incumbents completes the requisite service criteria and shall also verify genuineness of all the certificates produced by the candidates especially qualification certificates to the effect that they are valid and recognized by the H.P. Government, confidentially on priority basis and necessary entries to this effect be recorded in the Service Book of the official. Any lapse in this regard shall be viewed seriously and would be the personal responsibility of controlling officer.

In case the above officials desire to fix their pay under FR 22 read with rule 8 of Himachal Pradesh Civil Services Pay (Revised Pay) Rules 2022, they are required to exercise their option within one month from their promotion.

Before the above orders are implemented, the concerned Head of the Office will ensure that the promotees fulfil the appended conditions:-

- 1. The officials posted outside the radius of 25 KM are entitled for TTA/joining time.
- The above promotees after relieving will join at the place of his/her posting on promotion within or after availing the joining time as admissible under the rules as given below failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

- 3. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or till the next DPC or vacancy arises, which ever is later. In case of non acceptance of reason to forgo the promotion by the accepting/appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
- 4. The above promotion is subject to review due to any consequential administrative reasons.
- 5. Those who have been posted outside the sub cadre/tribal area will have to serve in these areas as and when it is administratively required.
- 6. That in case of any factual error/omission is detected later on, the promotion orders so issued will be withdrawn and concerned official shall have no claim for the same. The Controlling Officer will obtain an under taking to this effect from every promottee before they are relieved to next station or before joining.
- 7. <u>Before relieving the official to join the new place of posting on promotion it may be</u> <u>ensured that no fresh departmental inquiry/vigilance case is pending against the</u> <u>said official, if so same may be brought to the notice of this office immediately. The</u> <u>work and conduct of the official may also be kept in view before implementing the</u> <u>orders.</u>
- 8. The Head(s) of the office(s) concerned shall send relieving/joining reports of the promote (s) to this office immediately.
