OFFICE ORDER

Whereas Sh. Vinod Kumar, Sr. Asstt. from HPPWD 12th Circle Nahan has recently been transferred to HPPWD Divn. Shillai vice Sh. Saket Kumar Sr. Asstt. vide this e-office order No.632817 dated 13.06.2025 with the prior approval of competent authority conveyed vide U.O.No.Secy/CM-22056/2022-VIP-A-196509 dated 02.06.2025. Feeling aggrieved against these order, Sh. Vinod Kumar, Sr. Asstt. filed CWP No.10333 of 2025 titled Vinod Kumar Vs. State of HP & Others before the Hon'ble High Court of HP Shimla which has decided on 28.06.2025 with the following orders:-

5. "In view of above submissions and without interfering with the impugned transfer respondent No.5, this writ petition is disposed of by permitting the petitioner to prefer representation to the respondents/competent authority within four days, seeking his suitable transfer/adjustment, who shall in turn, consider and decide the same, in accordance with law and in terms of applicable Transfer Policy, within a further period of ten days. The order so passed be also communicated to the petitioner. Till such time, the petitioner shall not be compelled to join at the transferred station and he may avail the leave of kind due. In case the representation is not preferred by the petitioner within the indicated time-line, the protection made available to him under this order shall stand vacated.

Pending miscellaneous application(s), if any, shall also stand disposed of."

Further in compliance to the Hon'ble High Court direction Sh. Vinod Kumar, Sr. Asstt. vide his representation received in this office on 02.07.2025 has submitted the following:-

- 1. That he has already served hard area and may not be sent to Shilllai Divn.
- 2. That the seniority list of the Sr.Asstt. has wrongly been prepared by Sh. Himmat Singh, Sr.Asstt. just to save himself from transfer as Sh. Himmat Singh, Sr.Asstt. is posted there from last 13 years and he himself is at Sr.No. 4 of longer stayee officials.

- 3. That his mother is 80 years old on death bed and due to constant care of his mother, it is not possible him to join his duties in Shillai Divn.
- 4. That in case department wants to transfer him in that event he may be adjusted in HPPWD Divn. Sangrah against vacant post.
- 5. That Sh. Saket Kumar, Sr.Asstt. who has joined in HPPWD 12th Circle Nahan in his place is unable to work on his seat and desire to go back to Shillai, and as such his order may be cancelled.it is also pertinent to mention here that Sh. Saket Kumar, Sr.Asstt. has been transferred from Shillai Divn. to HPPWD 12th Circle Nahan as per approval of Hon'ble CM on medical grounds of father of Sh. Saket Kumar who has been posted in HPPWD 12th Circle Nahan vice Sh. Vinod Kumar which has clearly been shown in the approval as mentioned above and now the official has again submitted his willing to serve in the O/o AE, Sub-Divn. Kamrau under Shillai Divn. against Sh. Virender Kumar, Sr.Asstt. who is under order of transfer from Nahan Divn. to Shillai Divn. vice Miss. Himani Vishal, Sr.Asstt. vide order No. 639428 dated 25.06.2025.

Promila Devi, Sr.Asstt. and Smt. Promila Devi, Sr.Asstt. being longer stayee posted in HPPWD 12th Circle Nahan (Nahan Station) is hereby transferred and posted in HPPWD Divn. Shillai with TTA/JT in place of Sh. Vinod Kumar, Sr.Asstt. with immediate effect in the public interest.
