OFFICE ORDER

Whereas, Sh. Dinesh Kumar, Supdt.Gr.II. while posted in HPPWD Elect. Divn. Palampur has been transferred to HPPWD LAO Kangra vide this office order No.3991-4000 dated 25.06.2025 with the prior approval of competent authority. Feeling aggrieved against these order Sh. Dinesh Kumar Supdt.Gr.II. has filed CWP No.10402 of 2025 titled Dinesh Kumar Vs. State of HP & Others before the Hon'ble High Court of HP Shimla which has now been decided by the Hon'ble Court on 28.07.2025 with the following Judgements: -

4. I have heard learned counsel for the parties and considered the case file. The incumbency position of the petitioner given in the instructions dated 08.07.2025 is as under

From the above incumbency position of the petitioner, it becomes evident that the petitioner has throughout remained posted only in District Kangra. In fact, he has served at Palampur station, district Kangra (present place of posting) for more than 12 years, out of his total 27 years of service. Petitioner's contention of his having short stay at Palampur station, therefore, is not tenable. In fact, petitioner has completed almost three years at Palampur station even from his current date of appointment there, i.e. 06.10.2022. Petitioner's assertion about his being a couple case and therefore entitled to concession under Clause 5.4 of the transfer policy, cannot be accepted given the fact that the respondent-State has accommodated him for over 12 years of service at one place-Palampur. Further, the petitioner belonging to State cadre, has been allowed to remain only in District Kangra. The concession/benefit cannot be granted to the petitioner forever. Under the impugned office order, the petitioner has been transferred once again within District Kangra, i.e. from Palampur to Kangra, which is stated to be at a distance of about 35 kilometers from his present place of posting.

Nonetheless, the fact cannot be ignored that respondent No.3 has also been serving only in District Kangra. He has also served for 19 years at Palampur station in District Kangra. In fact, learned Deputy Advocate General has placed on record copy of D.O. Note No.18064, dated 14.02.2025, approving transfer of respondent No.3 petitioner's place of posting. Copy of a U.O. note issued on 1.10.2022 has also been placed on record, petitioner whereunder. was beneficiary transferred on that basis to HPPWD Palampur. It is evident that both the petitioner and respondent No.3 are interested to serve only in District Kangra and within that District also at one particular place, viz. Palampur. Their entire service has been rendered in District Kangra with major tenure at Palampur. They both are beneficiaries of D.O./U.O. notes in past.

5. In view of above, the impugned office order dated 25.06.2025 (Annexure P-1), relocating them in District Kangra deserves to be interfered with. It is accordingly quashed and set aside. Respondent No.2 is directed to consider the respective cases of the petitioner and respondent No.3 for transfer afresh in accordance with law and applicable transfer policy as also keeping in view the incumbency position of both the incumbents as noticed above. This exercise be carried out within a week from today.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous ap plication(s), if any.

Kangra and required to be transferred to any other office of HPPWD as per observation of Hon'ble High Court as well as per transfer policy of the State as both officials has rendered their major tenure at Palampur station. Accordingly with the prior approval of competent authority, transfer order of these Supdt.Gr. II. i.e petitioner as well as respondent are hereby ordered as under with immediate effect in the public interest:
