THEREFORE, the re-engagement of S/Sh. Pasang Negi, Superintending Engineer, HPPWD Circle Rampur and Harsh Puri, Superintending Engineer, HPPWD Circle Una as issued vide notification(s) dated 30.04.2025, is to be treated as reengaged against above created ex-cadre posts as a personal measure on fixed amount for a period of six months w.e.f. 01.05.2025 onwards on usual terms and conditions of Finance Department issued from time to time, in the public interest.
