ORDER

WHEREAS, Sh. Roshan Lal, Superintendent Gr. I (Adhoc) (Retired) alongwith 09 others has filed CWPOA No. 1801/2019 claiming therein the regular promotion to the post of Superintendent Grade-I from the date of their adhoc promotion etc.;

AND WHEREAS, aforesaid petition was listed before the Hon'ble High Court on 04.12.2025 when the Hon'ble High Court was passed pleased to pass following order:-

"Pursuant to orders dated 19.11.2025 and 26.11.2025, the records have been produced.

2. *Records reveal that 23 Superintendent Grade-II including the petitioners were promoted as Superintendent Grade-I on adhoc basis against vacancies of 2008-2009. They continued as such and they retired prior to holding regular DPC for Superintendent Grade-I on 29.09.2010, whereby, in-service Superintendent Grade-II were considered and recommended for promotion Superintendent Grade-I and not the retirees-petitioners at the time of holding regular DPC.*

3. *Records indicate that regular DPC was convened on 29.09.2010 convened for the vacancies of 2008 and 2009 and no norms have been pointed out which exclude the petitioners for against the vacancies of 2008-2009.*

4. *During the course of hearing Learned State Counsel places reliance Instructions dated 25.06.2013 [Annexure 16.77] to assert that the persons who have retired are not to be considered, when, the Instructions of 25.06.2013 [Annexure 16.77]) cannot be made the*

basis for not considering the petitioners for promotion by DPC convened on 29.09.2010 and when, the DPC has to abide by the norm of year-wise vacancy and year-wise officer(s) which seems to have been violated in instant case.

5. *Factual matrix and the records narrates a sorry state of affairs. Once the DPC was convened on 29.09.2010 for post of Superintendent Grade-I, against the vacancies of 2008 and 2009, which were occupied by the petitioners on adhoc basis, then, even though they stood retired prior to regular DPC, then also, the petitioners ought to be considered and upon being found fit/meritorious, to be promoted as such, though notionally at least for pay fixation and retiral benefits, when, the juniors were promoted against such vacancies.*

In these circumstances, without disturbing the incumbents promoted as Superintendent Grade-I on the basis of DPC held on 29.09.2010, the State Authorities, as prayed for by Learned State Counsel, is permitted to re-look into the issue so as to carve out a balance between the fundamental right of consideration available to the petitioners for promotion as Superintendent Grade-I [against the vacancies of 2008 and 2009, on which the petitioners were working as Superintendent Grade-I (adhoc) vis-à-vis the incumbents promoted actually on the basis DPC, by considering to grant notional benefits to the petitioners for retiral benefits.

6. *Prayer of Learned State Counsel appears to be genuine so as to enable the State to re-look into the issue.*

Let entire exercise be undertaken by the State Authorities within 03 weeks and necessary affidavit be filed by Respondent No.1.

Photocopies of the DPC records have been placed in a sealed cover, which shall form part of case file. Original records have been seen and returned so as to produce it again on the next date of hearing."

AND WHEREAS, the matter was examined and found that names of S/Sh. Mohan Singh & Puran Chand were recommended by the DPC in its meeting held on 13.06.2007 for regular promotion to the post of Superintendent Grade-I but their promotion orders on officiating basis were issued prior to their seniors and 47 numbers of Superintendent Grade-II were promoted to the post of Superintendent Grade-I on adhoc basis during year 2008 to 2010 in view of Government instructions dated 05.04.2008, out of which 26 were retired before their regular promotion. Further, as per directions of Hon'ble High Court and after examination of the matter in consultation with the advisory department(s), the DPC dated 22.09.2010 has been reviewed on 12.03.2026; and

NOW THEREFORE, after scrutiny the record & upon the recommendation of review DPC dated 12.03.2026, the following Superintendent Grade-II are promoted to the post of Superintendent Grade-I on regular basis from the dates shown against them **purely on notional basis**, as under:-


