OFFICE ORDER

On the recommendation of Departmental Promotional Committee, Sh. Ramesh Kumar (D.o.B. 08.03.1969), HDM working in the Level 12 of HPCS (Revised Pay) Rules, 2022 is hereby promoted to the post of Circle Head Draughtsman in the Level 13 of HPCS(Revised Pay) Rules, 2022 on regular basis with immediate effect in the public interest.

In case the above official desire to fix their pay under FR 22 read with Rule 8 of Himachal Pradesh Civil Services Pay (Revised) Rules, 2022 he is required to exercise their option within one month from the dated of promotion order.

Consequent upon his promotion to the post of Circle Head Draughtsman in the Level -13, the posting orders is hereby made as under with immediate effect in the public interest:-

The official shall be entitled for TTA/JT.

Before the above orders are implemented, the concerned Head of the office will ensure that the promotee fulfil the appended condition(s):-

1. The above promotee will join at the place of his/her posting on promotion within 5 days from the date of issuance of this order failing which the promotion orders shall deemed to be withdrawn automatically for one year.
2. The above promotee has no right to forgo the promotion in public interest and promotion can be enforced. However, if he applies to adduce for refusal of promotion to the appointing authority, then during the period of validity of the panel, no fresh offer of appointment on promotion shall be made for to him for a period of one year from the date of refusal or till a next vacancy arises whichever is later. In case of non-acceptance of reasons to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
3. The above promotion is subject to review due to any consequential administrative reasons.
4. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from the promotee before he is relieved on promotion to the next station.

5. Before relieving the official to join the new place of posting on promotion it may be ensured by the HOO that no fresh departmental inquiry/vigilance case is pending against the said officials.
