“OFFICE ORDER”

In pursuance of the Secretary(Personnel) to the Government of Himachal Pradesh letter No. PER(AP)C-B(2)-1/2014-V.II dated 01.04.2026, and on the recommendations of Departmental Screening Committee, the services of Sh. Rajesh Kumar, Junior Engineer (Civil) working on contract basis who has completed two years of continuous service as on 31.03.2026 is hereby regularized in the pay scale of Level 11 of HPCS (RP) Rules, 2022 with immediate effect as under:-

The above official shall continue to work at present place of posting after his regularization.

The above regularization is subject to the following conditions:-

1. Sh. Rajesh Kumar, Junior Engineers(Civil) is to be allowed to join on regularization if he completed minimum 2 years continuous service on contract basis as on 31.03.2026. Apart from this, it may also be ensured that no fresh Departmental inquiry/ Vigilance case is pending against the above official. If in any case it comes to the notice of controlling officer, the matter may be brought to the notice of this office.
2. The above contractual appointee so regularized shall be fixed at the minimum of the time scale of the post.
3. The regularization shall be subject to verification of character and antecedents, as provided under relevant rules.
4. His appointment shall be subject to the production of Medical Certificate of fitness from the District / Medical Officer of the Govt. Hospital.
5. He is liable to service in any part / area where HP PWD has its organization.
6. He is required to produce all original certificates in support of his qualification / technical education, age, Citizen of India and belonging to any reserved class, if any, against which he is proposed to be appointed at the time of joining the post.
7. He shall have to submit assets & liability statement.
8. He should give a declaration that he has not more than one living spouse.
9. He shall be governed by the CCS & CCA Conduct Rules.




10. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
11. The regularization shall be, subject to the provisions of the Himachal Pradesh Recruitment & Conditions of Service of Government Employees Act, 2024.

12. He will be required to take oath affirm on the following form.


