The said work was inspected by the undersigned alongwith all the above named Officers/officials. At the time of inspection of Admn.block, finishing work, form work of 3rd floor of academic work RCC slab was in progress. RCC work in Type-IV qtr. and Canteen block was in progress. During the course of the inspection, following observations/short comings were noticed.

The progress of execution of work by the contractor is very slow. Till now only 55% of the work has been completed. The stipulated date of completion of work is 18.04.2021. The Executive Engineer is directed to obtain the revised working programme from the contractor and ensure the completion of work by the said date, or else take action under the clause of agreement for not achieving the required mild stone, when the mentioned time. The preference should be given to complete the administrative block in all respects within two months.

Honeycombing has been noticed at certain locations, in administrative block and workshop block, which should be rectified and quality of concrete be improved. Further, form work & reinforcement has been placed and provided in the sloping slab which should be laid properly to avoid any leakage in future.

The columns of the Type-IV quarters are not in plumb lin. The mid landing of the stair case is also deflected, these defects be rectified immediately.

The quality control register were not shown during the inspection, the same should be shown to the Superintending Engineer, 9th Circle within two days. The frequency C.C.cubes sampling be ensured as per IS 456 and quality control register should be maintained properly. The locations, from where these samples have been taken to clearly mentioned in the quality control register henceforth.

The form work of columns beam joints in type-IV block had not been provided properly provided at certain locations and concrete cover on these joints was found on lesser side. Contractor is advised to be careful infuture while providing the form work in the column beam joints...
