In case any information is received by PWD officials regarding any defect/ discrepancy, the same will be reported to this office without waiting for the expiry of the period of one year.

Please note that in case of adverse report on performance of your firm/ Products received from field offices, approval given here can be cancelled at any point of time during the currency of approval period without waiting for the expiry of period of one year.

The approval does not make the firms eligible for claiming right to get the work or/items done procured through them only. Work/procurement is subjected to firm's competitive offers against other competing manufactures/brands /suppliers.
