1	RS-1(Rapid setting Emulsion) for Tack coat
2	CSS-1(Water based slow setting Emulsion) for prime coat
3	SS-1(Oil based slow setting Emulsion) for prime coat
4	RS-2 for Surface Dressing
5	SS-2 for Soil Stabilization
6	MS(medium setting) for Patch Repair
7	CQs(Cationic Quick Setting Emulsion) for Micro surfacing Layer

Each lot of material supplied must be accompanied with manufactures test certificates from NABL accredited labs. The independent quality control tests shall be conducted on every lot of supply . The material supplied should fulfil all the norms and specifications of latest relevant code of BIS.

This approval is valid for one year initially and further continuation of the approval of the product shall be decided. Thereafter, based on the mandatory feedback/ performance report submitted by the Executive /Superintending /Chief Engineers of HPPWD and valid BIS certificate. In case any information is received by PWD officials regarding any defect/ discrepancy, the same will be reported to this office without waiting for the expiry of the period of one year.

Please note that in case of adverse report on performance of your firm/ Products received from field offices, Approval given here can be cancelled at any point of time during the currency of approval period without waiting for the expiry of period of one year.

The approval has been granted on the basis of document/information furnished by the firm. The approval would be cancelled if any details are found different from the details already furnished during the inspection of manufacturing unit, PWD Himachal Pradesh reserves the right to visit the manufacturing unit at any time.

Raw material used for the production of bituminous product should be procured from a Public Sector Undertaking i.e., IOCL, Hindustan Petroleum, etc.
