Sub:- Request for an empanelment of Bituminous products in Himachal Pradesh PWD. { Waterproofing membranes (2mm,3mm,4mm), Bitumen Emulsions (All grade), Cold Mix Emulsion, Primers & Adhesives, Liquid waterproofing membranes, Construction chemicals, Admixtures, Road marking paints (Thermoplastic), Polysulphide Sealants, Anti – Stripping Agents}

With reference to your office letter referred above the technical committee in its meeting held on 27-12-2019 has recommended the following products of your company on pilot basis with following terms and condition for a period of one year.

a) RS-1, RS-2, SS-1, SS-2 & MS.

The raw material used for the production of emulsion should be procured from PSU's (Indian Oil Corporation or Hindustan Petroleum) Each lot of material supplied must be accompanied with manufactures test certificates from NABL accredited labs. The Lot wise independent Quality Control tests shall be conducted on each supply lot.

The materials supplied should fulfil all the norms and specifications of latest relevant code of IRC/IS. This approval is valid for one year initially and further continuation of the approval of the product shall be decided, thereafter based on the mandatory feedback/performance report submitted by the Zonal Chief Engineers & Chief Engineer (NH).

The approval does not absolve off the Executive/Supervisory staff from their responsibility for using correct quality products. Mandatory checks about the quality will be carried out as laid down and the records of the same be maintained.

Please note that approval given here can be cancelled at any point of time during the currency of approval period, in case of adverse report on performance of your firm/Products received from field offices without waiting for the expiry of period of one year.


