Short Listing Criteria

A. Annual Turn Over

- (i) Annual turnover of any one of the last 5 financial years i.e. from 2018-19 to 2022-23 updated to the current financial year shall be more than Rs. 10.00 crores. In case of JV, the lead member shall have more than Rs.10.00 crore of annual turnovers (updated) of any one of the last five financial years. This threshold for each other member of JV shall be more than Rs. 5 crores.
- (ii) For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement/updating factor corresponding to that year given in the **Annexure-II**.

B. Experience

The Consultant as Prime Consultant must have experience as follows:

- A. At least Two similar assignments of equal to or more than 8.00 Crores as Project Management Consultant for projects having overall cost not less than 500 Crores including preparation of DPRs . For JV, qualifying value for lead member would be 5 crore for projects having overall cost not less than 200 Crore and for other partner it would be 3 crore for projects having overall cost not less than 200 Crore. Such work must have been completed within last five calendar years including 2019.
- B. Experience having working as PMC for road works using FDR technology and stabilization will be given preference
- a) Experience of working in hilly region shall be given preference.

C.ORGANISATIONAL STRUCTURE & PERMANENT STAFFING:

- (a) At least 5 years in the business of Project Management Consultancy for Road Sector with minimum 10 roads (minimum 100 kms) of construction of roads using FDR technique . The experience of road construction in hill areas shall be preferred.
- (b) Permanent Key-Staff for the consultancy services as per Annexure V-.

A Work would qualify as similar work if it meets with following :

- a. Project management Consultancy for road works
- b. Supervision Consultancy for road works
- c. Work execution using FDR techniques for road works.
- d. Provides Project Construction Management Assistance on road works.
- e. Consultant must satisfy A, B and C for becoming eligible for short-

listing.
