(1) In all cases of promotion, the adhoc service rendered in the feeder post up to 31.3.91, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Rules for promotion subject to the condition: that in all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on adhoc basis upto 31.3.91) in the feeder post in view of the provisions referred to above, all persons senior to him in the respective category/ post/cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration;

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years or that prescribed in the Recruitment and Promotion Rules for the post, whichever is less;

Provided further that where a person becomes ineligible to be considered for promotin on account of the requirements of the preceding proviso, the persons(s) junior to him shall also be deemed to be ineligible for consideration for such promotion.

Explanation: The last proviso shall not render the the junior incumbents ineligible for consideration for promotion if the senior ineligible persons happened to be ex-servicemen recruited under the provisions of Rule-3 of Demobilised Armed Forces. Personnel(Reservation of Vacancies in Himachal State Non-Techanical Services) Rules, 1972 and having been given the benefit of seniority thereunder or recruited under the provisions of Rule-3 of Ex-Servicemen(Reservation of Vacancies in the Himachal Pradesh Techanical services) Rules, 1985 and having been given the benefit of seniority thereunder.

Similarly, in all cases of confirmation, adhoc service rendered on the feeder post up to 31.3.91, if any, prior to the regular appointment against such post shall be taken into account towards the length of service;

Provided that inter-se-seniority as a result of confirmation after taking into account, adhoc service rendered upto 31.3.1991 shall remain unchanged.

RESTRICT TO SUBJECT AND LOS OF THE PROPERTY OF THE PROPERTY. prescribed under these Rules after attaining the age of . 50 years for the purpose of crossing of efficiency bar next due.

An officer on promotion to this post shall not be required to pass the aforesaid Examination if he has already passed the same in the lower gazetted post.

(3) The Government may in consultation with the H.P.P.S. In exercise of the powers conferred by proviso to Article 309 of the constitution of India, the Governor, Himachal Pradesh, in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following Rules further to amend the Himachal Pradesh, Public Works Department, Chief Engineer (Civil) Class-I (Gazetted), Recruitment and Promotion, Rules, 1997 notified vide this Department notification of even number dated 24.4.1997, namely:

Short title and commencement

- (i) These rules may be called the Himachal Pradesh Public Works Department, Chief Engineer. (Civil) (Class-I, Gazetted), Recruitment, and Promotion (First amendment) Rules. 2005.
- (ii) These rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

Amendment of Annexure-"A"

- In Annexure- A" to the Himachal Pradesh Public Works Department, Chief Engineer (Civil) (Class-I, Gazetted) Recruitment and Promotion Rules. 1997:
- (a) For the existing provision against Col.No.2, the following shall be substituted namely:

- (c) For the existing Col.No.10 and provision against Col.No.10, the following shall be substituted, namely:-

(d) For the existing provision against Col.No.11, the following shall be substituted namely:-

By promotion from amongst the Superintending Engineers (Civil) with minimum 25 years' service in gazetted rank including three years' regular service or regular combined with continuous adhoc service as Superintending Engineer (Civil) failing which on secondment basis from amongst the incumbents working in the identical pay scale on analogous posts in other H.P. Government Departments/Central Government with similar service conditions.

(1) In all cases of promotion, the continuous adhoc service rendered in the feeder post, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Rules for promotion subject to the condition that the adhoc appointment/promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provisions of R&P Rules;

Provided that in all cases where a junior person becomes eligible for consideration by virtue of his/her total length of service (including the service rendered on adhoc basis, followed by regular service/ appointment) in the feeder post in view of the provision referred to above, all persons senior to him/her in the respective category/post/cadre shall be deemed

to be eligible for consideration and placed above the junior person in the field of consideration.

Provided further that all incumbents to be considered for promotion shall possess the minimum qualifying service of atleast three years or that prescribed in the R&P Rules for the post, whichever is less.

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the proceeding proviso, the person(s) junior to him/her shall also be deemed to be ineligible for consideration for such promotion;

Explanation - The last proviso shall not render the junior incumbent(s) ineligible for consideration for promotion if the senior ineligible person(s) happened to be ex-servicemen recruited under the provisions of Rule-3 of the Demobilized Armed Forces Personnel (Reservation of vacancies in Himachal State Non-Technical Services). Rules, 1972 and having been given the benefit of seniority thereunder or recruited under the provisions of Rule-3 of the Ex-servicemen (Reservation of vacancies in the Himachal Pradesh Technical Services). Rules, 1985 and having been given the benefit of seniority thereunder.

2) Similarly, in all cases of confirmation, adhoc service rendered on the feeder post, if any, prior to the regular appointment/promotion against such post shall be taken into account towards the length of service; if the adhoc appointment/promotion had been made after proper selection and is accordance with the provision of the R&P Rules:

Provided that inter-se-seniority as a result of confirmation after taking into account, adhoc service rendered as referred to above shall remain unchanged.

(e) For the existing provision against Col.No.16, the following shall be substituted namely:-

"The appointment to the service shall be subject to orders regarding reservation in

the service for Scheduled Castes Scheduled Tribes Other Backward Classes Other categories of persons issued by the Himachal Pradesh Government from time to time."

(f) For the existing provision against Col.No.17, the following shall be substituted namely:-

Every member of the service shall pass a Departmental Examination as prescribed in the HP Departmental Examination Rules, 1997 as amended from time to time.
