NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh in consultation with the H.P. Public Service Commission is pleased to make the Recruitment and Promotion Rules for the post of Circle Head Draughtsman (Class-III, Non-Gazetted) in Public Works Department, Himachal Pradesh as per Annexure-A attached to this notification, namely:-

Short title and
Commencement

1. (1) These rules may be called the Himachal Pradesh Public Works Department Circle Head Draughtsman (Class-III, Non-Gazetted) Recruitment and Promotion Rules, 1996.

- (2) These Rules shall come into force from the date of their publication in the Rajpatra, Himachal Pradesh.

Repeal and Savings.

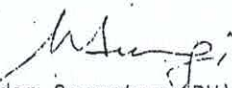
2. (1) The Himachal Pradesh Public Works Department, Subordinate Service Class-III Draughtsman and Tracer Service Recruitment and Promotion Rules, 1961, notified vide Notification No. PBW-147/67-II-4887 dated 18-1-1961 are hereby repealed to the extent these were applicable to the post of Circle Head Draughtsman in the Public Works Department.
- (2) Not with standing such repeal any appointment made or anything done or any action taken under the rules, so repealed under sub-rule 2 (1) supra shall be deemed to have been validly made, done or taken under rules.

RECRUITMENT AND PROMOTION RULES FOR THE POST OF CIRCLE HEAD
DRAUGHTSMAN (NON-GAZETTED) Class-III IN THE HIMACHAL PRADESH PUBLIC
WORKS DEPARTMENT.

1. Name of the post: Circle Head Draughtsman
2. Number of the post: 13 (Thirteen)
3. Classification: Class-III (Non-Gazetted)
4. Scale of pay: Rs. 2130-70-2550-75-2000-100-3700.
5. Whether selection post or Non-Selection post: Non Selection.
6. Age for direct recruitment: Not applicable.
7. Minimum Education and other Qualifications required for direct recruits: Not applicable.
8. Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees: Age: Not applicable.
Educational Qualification: Not applicable.
9. Period of probation if any: whether by direct recruitment or by promotion, deputation transfer and the percentage of vacancies to be filled in by various methods. Two years subject to such further extension for a period not exceeding one year as may be ordered by the competent authority in special circumstances and reasons to be recorded in writing.
10. Method of Recruitment: whether by direct recruitment or by promotion, deputation transfer and the percentage of vacancies to be filled in by various methods. 100% by promotion.
11. In case of recruitment by promotion deputation, transfer grade from which promotion/deputation/transfer is to be made. By promotion from amongst the Divisional Head Draughtsman who possess Diploma in Draughtsman Trade with three years regular service or regular adhoc (rendered upto 31.3.91) service in the grade, if any.

(2)(f)

In all cases of promotion the adhoc service rendered in the feeder post upto 31.3.1991 if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Rules for promotion subject to the condition:

(1) that in all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on adhoc basis upto 31.3.91) in the feeder post in view of the provisions referred to above, all persons senior to him in the respective category/post/cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration:

Provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years or that prescribed in the Recruitment and Promotion Rules for the post, whichever is less.

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the preceding proviso, the persons junior to him shall also be deemed to be ineligible for consideration for such promotion.

Explanation:

The last proviso shall not render the junior incumbents ineligible for consideration for promotion if the senior or ineligible persons happened to be ex-servicemen recruited under the provisions of Rule-3 of Demobilised Armed Forces Personnel (Reservation of Vacancies in Himachal Pradesh State Non-Technical Services) Rules-1972 and having been given the benefit of seniority thereunder or recruitment under the provisions of Rule-3 of Ex-servicemen (Reservation of Vacancies in the Himachal Pradesh Technical Services) Rules-1985 and having been given the benefit of seniority thereunder.

(2) Similarly, in all cases of confirmation, adhoc service rendered on the feeder post upto 31.3.91 if any prior to the regular appointment against such post shall be taken into account towards the length of service:-

Provided that inter-se-seniority as a result of confirmation after taking into account, adhoc service rendered upto 31.3.91 shall remain unchanged.

12. If a Departmental Promotion Committee exists what is its composition:

As may be constituted by the Government from time to time.

13. Circumstances under which the H. P. P. S. C. is to be consulted in making recruitment.

As required under the Law.

14. Essential requirement for a direct recruitment.

15. Selection for appointment to post by direct recruitment.

Selection for appointment to the post in the case of direct recruitment shall be made on the basis of viva-voce test if the HPPSC or other recruiting authority as the case may be, so consider necessary or expedient by a written test or practical test, the standard/syllabus etc. of which will be determined by the commission/other recruiting authority as the case may be.

16. Reservation.

The appointment to the service shall be subject to orders regarding reservation in the service for schedule castes/ Schedule Tribes/Backward Classes/other categories of persons issued by the Himachal Pradesh Govt. from time to time.

17. Power to Relax:

Where the State Govt. is of the opinion that it is necessary or expedient to do so it may by order for reasons to be recorded in writing and in consultation with the HPPSC relax any of the provisions of these Rules with respect to any Class or Category of persons or posts.
