1. Eligibility:-

Only such candidates shall be eligible to apply for the post of Para Cook and Para Helper (Lok Nirman) who is :-

- 1. Citizen of India.
- 2. Bonafide Himachali.
- 3. Of a Sound Mind.
- 4. No family member of the candidate(s) should be in kind of Government/PSU/Board job.
- 5. Have never been involved in any Act of Criminal nature.
- 6. Medically fit to perform duties.
- 7. Permanent resident of the concerned HPPWD Circle.

2. Educational Qualification:-

- Para Cook:- 1. The candidate should have passed Matriculation examination from a school/Institution situated within Himachal Pradesh. The condition of passing 10th from Himachali School shall not be applicable to Bonafide Himachali.
 - 3. The candidate should possess at least 6 months diploma in cooking from Food Production Institutes or Hotel management institute of repute including State Institute of Hotel Management (SIHM), Institute of Hotel Management (IHM) etc., or 5 (Five) years experience in cooking from duly registered public/private institution.

Para Helper:- The candidate should have passed Matriculation examination from a school/Institution situated within Himachal Pradesh. The condition of passing 10th from Himachali School shall not be applicable to Bonafide Himachali.

Desirable:- Knowledge of customs, manners & dialects of Himachal Pradesh.

- 4. Age Criteria:- The candidate shall be between the age of 18 to 45 Years.
- 5. Applications: The candidates will have to apply on format prescribed, along with self attested photo copies of certificates to the concerned Executive Engineer of the Division who will compile all the applications received on or before the prescribed last date. The documents of the applicant shall be verified with the originals at the time of counseling. The concerned Executive Engineer will send a copy of such compiled list of applicants to the Superintending Engineer of the Circle.

4. Certificate to the effect that no family member of the candidate is in Government/PSU/Board job (Issued by SDO (Civil)/Tehsildar/Naib Tehsildar).

5. Class 10th (Matriculation) marks sheet/certificate of passing-educational

qualification.

6. BPL certificate (If applicable), (Issued by the concerned Gram Panchayat on the prescribed format with reference Number and date of issuance duly signed by concerned Panchayat Secretary/Sahayak & countersigned by concerned Gram Panchayat Pradhan and attested by the BDO concerned and in case of Urban area by Commissioner in Municipal Corporation, Executive Officer in Municipal Council, Secretary in Nagar Panchayats).

7. Experience certificate (If applicable). (Experience should be in a registered public/private institution and should be issued by the competent authority of the organization. Experience certificate must contain office reference number/dispatch number and date. Experience should be related to the post applied for).

7. Roles and responsibilities :-

All cooking and food service related duties in the Rest House/Circuit House including :-

- a) To service meals to the guests at the designated hour in hygienic conditions.
- b) To clean the kitchen and utensils and store the utensils in a hygienic conditions.
- c) To help in procurement/transportation of material for cooking and service.
- d) Any other cooking/cleanliness related miscellaneous job assigned.

8. TERMS AND CONDITIONS OF SERVICE:-

- a) The selected incumbent will be paid honorarium at the rate of Rs. 9000/- PM for Para Cook and Rs. 5500/- PM for Para Helper.
- b) Keeping in view the nature of work, the Cook/Helper should attend the duties on all days including Gazetted Holidays for fixed number of hours.

c) Continuous absence beyond 7 days from duties without approval of competent authority shall automatically lead to the termination of the services of the Cook/Helper. The cook/Helper will not be entitled for any wages/remuneration for the period of absence.

d) The Cook/Helper should be medically fit and free from any contagious disease. If a person is found medically unfit/suffering from any contagious disease subsequently,

his appointment will be terminated.

- e) Unsatisfactory performance may result in termination of appointment by passing an order. The process of termination shall however not be completed unless at-least 3 notices have been served upon the incumbent on a specific charge and there has been no improvement in service delivery. The concerned Junior Engineer would have to substantially put down in written the reasons for such termination and this would need to be countersigned by concerned Assistant Engineer based on record/technical reasons.
- f) The candidates appointed as Para Cook/Para Helper (Lok Nirman) will have no right, claim for regularization as regular employee of the State Government.
- 9. The Government of Himachal Pradesh shall have the right to relax/amend any of the terms and conditions/provisions mentioned in the above scheme/policy in public interest.
