Whereas Sh.Ghanshyam, Clerk (Now Senior Assistant) has made a representation wherein he has submitted that his date of appointment is 02.01.2006 on daily wages (due to 01.01.2006 Sunday) instead of 06.01.2006 and requested to correct his seniority as per date of appointment.

And whereas on the examination of the record received from the concerned field office i.e. the Executive Engineer, HPPWD Division Rajgarh, the official has been engaged on daily waged basis w.e.f. 02.01.2006 and the same also been verified from the quarterly staff strength return of the concerned office. From the perusal of the representation, it is also found that 01.01.2006 was Sunday.

And whereas in order to make the correction, the Seniority list of Clerk as on 31.12.2018 circulated vide letter dated 23.07.2020 was examined and found that the official at Sr.No.311,312,313 have been shown appointed w.e.f.01.01.2006, which was not possible being Sunday on 01.01.2006. The date of engagement of the official at Sr.No.312 has verified from the Quarterly Staff Strength Return received from the Executive Engineer, HPPWD Division Rajgarh, which is 02.01.2006. However, to verify the exact date of engagement of officials at Sr.No.311,313 namely Sh.Desh Raj & Sh.Ravinder Kumar, respectively the matter was taken up with the Executive Engineer, HPPWD Division Bharmour vide this office letters dated 05.07.2023, 02.08.2023, 30.08.2023, 10.10.2023, 14.11.2023, 06.04.2024.

And whereas the Executive Engineer, HPPWD Division Bharmour vide his letter No.PW-BD-EA-I-Clerk/2023-24-20587-88 dated 28.03.2024 submitted the copies of Muster roll of these officials for the month of January 2005. From the perusal of the same the officials have been found engaged w.e.f. 02.01.2006.

And whereas adequate time was granted to the officials for submission of their objections during circulation of the provisional Seniority list vide letter dated 19.06.2019, but no representation of the official(s) were received in this regard so far and after obtaining opinion of the Legal Cell of this office and as per the available record, the seniority list was finalized vide this office letter dated 23.07.2020. Further, no representation(s) from any official have been received.

However, keeping in view the genuinity of the documents received from the concerned offices, the request of the official is proposed to be considered in term of date of appointment and therefore the seniority list issued vide letter dated 23.07.2020 is proposed to be amended to the following extent:-
