Most humbly and respectfully beg to submit the following for your very kind consideration and issuing necessary orders please ..---

Sir there has always been a debate on eradication of corruption in public procurement and the state government has always been endeavoring to eradicate corruption from public procurement and some success has been achieved by the government by taking some measures like use of information technology to achieve the same. But there is always room to bring in new measures to make the public procurement more transparent and eradicate corruption from it.

I would like to suggest one such measure which the Government may consider for implementation please.

In Himachal Pradesh Public Works department which is the biggest department doing public expenditure for doing and executing the big infrastructural works, construction of rods, steel and rcc. bridges, buildings, procurement of bitumen ,spare parts, machineries, equipments, electrical fittings etc. all these public procurements are being done through field divisional offices and store purchase officers in head office. The Executive Engineers who are doing these procurements be MAN²²through online tenders or offline tenders remain posted at the same station for more than three years giving rise to patronisation of contractors, developing nexus with local politicians and contractors which becomes stronger with the longer period of stay at one station. Local politicians and contractors who are in connivance with the officers manage them to retain

same station for more than three years which gives rise to corruption d thereby decreasing the quality of work. The recent damages of roads bridges, buildings in the state in this rainy season can also be attributed to low quality works.

Comprehensive guiding Principles of transfers dated july 2013 vide clause 10 provides for normal stay at one station for 3 years. But the Executive Engineers in HPPWD in many places who are doing public procurements are posted at one station for many years and the nexus between the contractors and politicians are playing all sorts of tricks for not getting them transferred.
