
I am directed to refer to the Director, FCD, Department of Expenditure, Ministry of Finance GoI letter no. F.No.1(13)PFMS/FCD/2020 and also notification issued by RBI authorizing private sector banks for Government business subject to approval by the State Government.

The matter regarding authorization of private sector banks for government business in Himachal Pradesh was considered by the Government and it was decided that private banks will be authorized for government business on

202 case to case basis. Accordingly, the request of Bank of Baroda for authorization for government business was considered and it was decided that the Bank of Baroda will be authorized for conduction of government business in the state.

Therefore, the departments may consider Bank of Baroda for opening of State Nodal Account and subsidiary accounts for implementation of Centrally Sponsored Schemes in the state in addition to public sector banks already authorized for conduction government business.
