3. The contractor/firm shall have applied to the Income Tax Officer of the area in which he assessed for grant of Income Tax Clearance Certificate in the month of May every year. The tax clearance certificate shall be submitted to the Chief Engineer concerned by the end of June every year. If he fails to submit the tax clearance certificate or fails to show any justified reasons for Non supply of Income Tax Clearance Certificate his name will liable to be removed from the approved list of the contractor of this department.




