OFFICE MEMORANDUM

Subject:- Grant of Conveyance Allowance to blind and orthopedically Handicapped Government Employees.

I am directed to enclose herewith a copy of Office Memorandum vide NO.Fin.(C)B(15)-2/2015 Dated 21st April, 2020 received from Finance Department of Himachal Pradesh whereby it has been conveyed that Conveyance Allowance of blind and orthopedically handicapped Government Employees has been raised from Rs.500/- to Rs.750/-p.m. in respect of those employees who are blind or are at least 70% orthopedically handicapped. However, in case of those Government employees where the percentage of disability is below 70%, the existing rate of Conveyance Allowance mentioned in O.M. dated 12th May, 1986 shall continue to be allowed. The conveyance allowance at the above rate shall be admissible w.e.f. 1st April, 2020.

It is, therefore requested to take immediate necessary action on the above accordingly.




