

Grant of daily wages to Part Time Workers converted as Whole Time Contingent Paid/ Daily Waged workers- Instructions regarding.

Sir/Madam,

I am directed to refer to the subject cited above and to say that the matter with regard to grant of daily wages to those Part Time Workers converted as Whole Time Contingent Paid/ Daily Waged workers was engaging the attention of the Government for the some time past. The Division Bench of Hon'ble High Court of Himachal Pradesh, vide judgment dated: 12.12.2011 given in CWP No. 3310 of 2011-D titled as Leela Devi Vrs. State of Himachal Pradesh & others, and other connected matters in case of Education Department, had directed the State Government to consider that the cases of all those Part Time Water Carriers, who have completed 10 years of service as such, shall be converted to the status of Whole Time Contingent Employees on daily waged basis (with no retrospective effect).

2. The Government, after due consideration and in compliance to the judgment dated: 12.12.2011 of Hon'ble High Court, has decided that all the Part Time Workers in different government departments, on conversion as Whole Time Contingent Workers or Daily Waged Workers, as the case may be, will be allowed daily wages, as fixed by the Government from time to time.

3. These instructions shall supersede all the previous instructions issued by the Government regarding norms for fixation of emoluments of whole time contingent paid employees.
