

Copy of letter No.Home (Vig) E (3)-14/2010- Part-IV dated 5.8.2015 from Joint Secretary (Vigilance) to the Govt. of Himachal Pradesh, addressed to all the Administrative Secretaries to the Govt. of HP.

Subject: - High Court's order dated 18.11.2013 in CWP NO. 4916/2010, Sher Singh Vs State of H.P. & others (instructions thereof-regarding posting of officers/ officials having doubtful integrity).

I am directed to refer to this Department's letter of even number dated 25.11.2013 (which can be downloaded from the vigilance link of Home Department in the official website of State Government) and subsequent reminder dated 23.06.2014 on the subject cited above and to inform you that as per instructions issued, the officers/ officials having doubtful integrity are required to be posted on the non-sensitive posts and, if such officer(s)/ official(s), is/are being posted on sensitive posts in unavoidable circumstances, the prior approval of the Hon'ble Chief minister is required to be obtained by placing the fact before him stating that the name of officer(s)/ officials has/have been included and figure in the "list of officer of doubtful integrity".

You are, therefore, requested to kindly ensure and review at regular interval of 6 (Six) months that the said instruction, issued vide above referred letters, are being adhered to strictly by the Departments/ Boards/ Corporations and other autonomous institutions etc.


