It has been decided that in such cases where approval of Hon'ble Chief Minister has been conveyed for condonation of short stay, only such cases may be re-referred where the short stay of less than one year is required to be condoned. In other cases of short stay of 1 year of more, the orders may be implemented and such cases may not be referred back to Chief Minister office.
