I am directed to sent here with a copy of letter No. No. PBW (B) F (7) 3/2021 dated 12-11-2021 received from the Principal Secretary (PW) to the Govt., of H.P, for information. It was intimated that the issue relating to W and X forms/ Transit passes, imposition of royalty on process product /GST paid bills etc on Finished products of Minor Minerals was under consideration at the Govt., level and the proceeding of the meeting held with the Principal Secretary (PW) to the Govt., of H.P. on dated 1/11/2021 is received vide Govt., letter No. PBW (B) F (7) 3/2021 dated 12-11-2021.(copy enclosed)

Point No.-6. All the Executive Engineer are directed that where excavation/ cutting is component in the work, the quantity of stone/ aggregates

Proceedings of meetings held on 01.11.2021 at 11:00 AM under the Chairmanship of Principal Secretary (PW) to discuss the issues related to W and X Forms/Transit passes, imposition of royalty on process product/GST paid bills etc. on finished products of Minor Minerals.

At the outset, the Pr. Secretary(PW) welcomed all the participants and it was briefed that the Department is not clearing the bills of contractors who have not submitted X or W-Forms as per court direction issued in judgment dated 16.07.2020 in CWP 2395/2020-titled as Daljit Singh Pathania Vs. State of HP & ors. Contractors on the other hand have submitted that X or W-Forms are not being provided by crusher owners. The matter was discussed with all the participants, the Principal Secretary(PW) stressed that Public Works Department will not tolerate/support illegal mining but at the same time, it is is the responsibility of Mining Department to proactively check illegal mining. It was brought out by the participants that there is demand-supply gap which is causing shortage of X or W-Forms and also hampering execution of works of PWD. During the meeting, after detailed deliberations in the matter, the Principal Secretary(PW) imparted following directions:

- 1. Annual requirement of mining material by HPPWD such as aggregates, sand and stone etc. for various works may be procured Division wise from all Zones and consolidated requirement reflected to the Industries Department.
- 2. Industries Department may explore the possibility for mining and setting up of crushers through GIC/HPIDC etc. to cater to the needs of mining material required for construction of roads, bridges and buildings in the State.
- 3. Industries Department is requested to consider and direct crusher owners to make entry of W or X-Forms numbers in GST bills.
- 4. The bills which are submitted by the contractors without W or X-Forms, the concerned Executive Engineer will send copy of the bills of mining material to District Mining Officer of Industry Department for verification of source.
- 5. The E-in-C, HP PWD to respond by submitting the reply of petition in the Hon'ble High Court w.r.t. petition of Sh. Bhupinder Paul Mahajan Vs. State of HP within 7 days.
- 6. The Directions be issued to all Executive Engineers where excavation/cutting is component in the work, the quantity of stone/aggregates generated during cutting be certified and may be sent to Distt. Mining Officer for issuing of permits for using the material.
- 7. The Industries Department may amend its guidelines and delink developmental Departments from regulatory work in this regard.

The meeting ended with vote of thanks to the chair and vice-versa.
