Non-Adherence to Legal and Procedural Provisions by HPPWD Officers in Execution of Works in HPPWDinstruction thereof.

Sir,

I am directed to refer to the subject cited above and to say that serious irregularities being observed in the execution of various works by officers of the Himachal Pradesh Public Works Department as it has been noted with concern that several provisions of law and departmental procedures as detailed below are not being adhered to despite of repeated instructions issued by the Government / ENC, HPPWD / Hon'ble Courts, which is leading to administrative, financial, and legal complications :-

- 1. Execution of works without obtaining Administrative Approval (AA) and Expenditure Sanction (ES)
- 2. Execution of works in excess of the approved Expenditure Sanction
- 3. Execution of works without inviting tenders or through unauthorized awards
- 4. Granting of extension of time for completion of works without approval of the competent authority
- 5. Change in scope of works without prior approval of the competent authority
- 6. Tendering of works without completion of codal formalities
- 7. E-Tendering of works with estimated cost less than ₹1.00 lakh.

These actions are in clear contravention of the Himachal Pradesh PWD Code, CPWD Works Manual, and other applicable financial rules and guidelines. Such practices not only compromise transparency and accountability but also pose serious risks of audit objections, cost escalations, and legal complications.
