Non adherence of the clauses of Bid-document related to 'field laboratory' and Field Engineers' by contractors and Executive Engineers in PMGSY works.

In this context it has been observed that our field engineers and contractors are not adhering to the various contract clauses of the bid document in respect of Quality of PMGSY works. It is noticed that neither the field labs are being established properly on field by the contractors nor any engineer is being deputed on their job as per condition of the relevant clause of the agreement. It would be pertinent to mention that these clauses related to field lab and field Engineer play very important role in ensuring the quality of work and even otherwise also the contractor and Engineer both are bound to ensure its implementation under their contractual obligations.

These relevant clauses related to Quality are reproduced as under:-

## Section 2, Instruction to Bidders (ITB), Appendix to ITB mentions that:

(4.4B)(b)(ii) The Number of Technical personnel Qualification and experience will be as follows:

If the contractor fails to set up the field lab within prescribed period of 15 days from the date of notice to start work and does not deploy requisite machinery and equipment, it will be the fundamental breach of contract. The relevant extract of fundamental breach of contract in respect of quality lab etc. clause is 52.2 (i & j) which is reproduce as under:

- i) If the contractor fails to set up a field laboratory with the prescribed equipment within the period specified in contract Data.
- *j)* If the contractor fails to deploy machinery and equipment or personnel as specified in contract data at the appropriate time.
