NOTIFICATION

In exercise of the powers conferred by clause (2) and (3) of article 166 of the Constitution of India, the Governor, Himachal Pradesh, is please to make the following rules further to amend the Rules of Business of the Government of Himachal Pradesh, 1971 framed vide Order No.5-1/71-GAD(CC) Dated 25<sup>th</sup> January, 1971, namely:-

Short title and  
Commencement

1. (1) These rules may be called the Rules of Business of the Government of Himachal Pradesh (17<sup>th</sup> Amendment) Rules, 2018.

(2) These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

Amendment of  
SCHEDULE

2. In Sr. No. 15 of the SCHEDULE appended to the Rules of Business of the Government of Himachal Pradesh, 1971, after the first proviso, the following second proviso shall be added, namely:-

"Provided further that the Administrative Department shall be competent to create supernumerary posts with the prior concurrence of the Finance Department, without placing the matter for discussion at the Meeting of the Council."
