In partially modification to this department's Notification No. HFW-B(F)2-10/2018 dated 29/12/2018 and as amended from time to time, the Governor, Himachal Pradesh is pleased to order to amend/modify the "Mukhya Mantri Himachal Health Care Scheme- HIMCARE", with the new provisions as under:-

- I. The registration of new beneficiaries/preparation of fresh HIMCARE cards in the months of March, June, September and December shall be allowed for one year on the payment of premium on existing rates/norms. Policy period is for one year.
- II. The beneficiaries are required to give undertaking that none of their family members is covered under Govt. reimbursement schemes for employees and pensioners.
