Regarding waiving off Right of Way (RoW) charges for laying Optical Fibre Cable (OFC) in Tribal areas of Himachal Pradesh for 4G Saturation Project.

Sir.

I am directed to refer to your letter No. PW/Fiber Cable/DA-II/W.S./2022-23-795 dated 03-05-2023 with reference to subject cited matter and to convey the approval of the Government for laying Optical Fibre Cable (OFC) in Tribal areas of Himachal Pradesh by Bharat Sanchar Nigam Limited (BSNL) for 4G Saturation Project on following terms & conditions:

- 1. At places where new roads are being constructed, the BSNL may lay optical fibre after formation cutting work is completed, but well before start of M/T works.
- 2. At places where the road are being Up-graded under different schemes of the Government, the BSNL may lay optical fibre after the Removal Of Formation Deficiency (ROFD) work is completed but well before start of work of M/T otherwise.
- 3. At places where optical fibre cable is to be laid on metalled road, BSNL will restore the road to its original form to the satisfaction of Executive Engineer in-charge. Final inspection will be carried out jointly by officers of the BSNL/PWD after restoration of the road and thereafter the completion certificate shall be issued by the concerned Executive Engineer of HP PWD, failing which restoration charges have to be given by BSNL to HP PWD to restore the road.

This is for your information and further necessary action.
