Tentative Seniority list of Clerk as it stood on 31.12.2003,31.12.2006,31.10.2010& 31.08.2014 in HPPWD by virtue of the decision of the Hon'ble High Court in CWP(T) No. 9797/2008 and upon dismissal of SLP No.21468/2023.

In this regard, it is intimated that Smt. Dropta Devi W/o Shri Manoj Kumar R/o Village & Post Office Chanair, Tehsil Theog, District Shimla, H.P who was initially engaged as daily waged Beldar in the department w.e.f.01/05/1992 under Theog Diviosn HPPWD Theog and her services were regularized w.e.f. 12.09.2006 as per regularization policy dated 09.06.2006 and as per the verdict of the Hon'ble Apex Court in Mool Raj Upadhayay's case, retrospective benefit was given w.e.f. 01.01.2002 upon completion of 10 years of continuous service as daily waged Beldar.

The aforesaid Class-IV official during the year 2003 filed OA No.3264/2003 before erstwhile Hon'ble Himachal Pradesh Administrative Tribunal at Shimla, seeking therein directions to the respondents to consider her for the post of Typist from the date of her regularization w.e.f. 01.01.2002 with all consequential benefits. The Original Application was transferred to the Hon'ble High Court after abolition of the Tribunal and registered as CWP (T) No. 9797 of 2008 and same was allowed by the Hon'ble High Court through its judgment dated 17.09.2012 with the directions to regularize the petitioner as Clerk w.e.f. 1.1.2002, with all consequential benefits, however, the arrears were restricted to three years prior to the date of institution of the writ petition i.e. 18.11.2003.

In order to consider the claim of the applicant as per the directions

of the Hon'ble High Court, the matter was referred to the Govt. for examination and opinion, vide letter No.PBW-A-E(1)-184/2012 dated 07.02.2013 advised to assail the matter by way of filing the LPA in the matter. Accordingly LPA was filed by the department before the Hon'ble High Court and registered as LPA No.4040 of 2013 and after hearing said LPA was disposed off by the Hon'ble High Court through its judgment dated 13.10.2022 with its opinion that learned Single Judge had rightly allowed the writ petition filed by the respondent and therefore, no ground for interference by this Court, is made out. In the aforesaid, decision of the Hon'ble High Court in LPA No.4040/2013, The Govt. advised to the department to file SLP, Accordingly SLP was filed before the Hon'ble Apex Court and registered as SLP (C) No.21468/2023 which was dismissed by the Hon'ble Apex Court dated 25.09.2023 with the plea that " We are not inclined to interfere with the judgment impugned herein under Article 136 of the constitution of India and further as per opinion of the Govt. dated 26.02.2024, the order of the Hon'ble High Court on 17.09.2012 has attained finality. Keeping in view the facts as stated in the final judgment. The service of Smt. Dropta Devi has already been redesignated/regularized as Clerk w.e.f.01.01.2002 (i.e. from the date of regularization as Beldar) vide order No. PWE-82-1-Apptt. (4th Circle Shimla)/ES-I-6478-84 dated 08.08.2024. Accordingly, the seniority benefit is to be granted to her by adding her name in the existing seniority list as under:-
