In partial modification of this department notifications of even number dated 27th May, 2021 and 16th July, 2021, the guidelines regarding publicity and processing of tenders in HP PWD are amended as under:

Amendment in Para-3:

i). The words "7(Seven) days" shall be substituted by "10(Ten) days".

ii). The word "Giriraj weekly newspaper" shall be deleted.

Amendment in Para-4:

i). The words "14(Fourteen) days" shall be substituted by "10(Ten) days".

ii). The word "Giriraj Weekly" shall be deleted.

Insertion of Para-4A:

The processing time for tender notice of works costing above Rs. 1.00 Lakh would be as under:
